- Approval of March 29, 2024 Meeting Minutes- Approved
- Member updates- 15 minutes
 - Todd Altschuler- Community Crawl Proposal- Would like to do a community “food and bar crawl” in lieu of a community dinner.
 - Todd proposed that we try this as the FACC first with staff to see if it is doable. FACC said they would be interested in the FACC piloting this.
 - FACC agreed that Town Council be included and that they should find a way to incorporate art.

 - Summer schedule-
 - Frequency over May/June/July/August- FACC agreed to meet each month
 - Upcoming projects- Tunnel mural, rec path mural, movie night
 - July 4th Float Collaboration- FACC agreed to support up to \$3,000
 - July 4th stipend to launch on May 17 and staff to create a flyer for FACC to promote and circulate
 - July 4th- FACC agreed to reach out to mariachi band/horses and pay for this involvement- Jamie Callahan to pursue
- Project Discussion- 75 minutes
 - Exit 203 CDOT Project Discussion with Town of Frisco Public Works Director/Town Engineer Chris McGinnis (12:30pm-1:00pm)
 - Staff provided an overview of the project.
 - Sent a project website to FACC if they want to provide feedback to CDOT
 - Staff asked the FACC to weigh in on some design decisions
 - Signs- FACC asked staff to look at font sizes and clean/simple fonts and design general, make signage less urban than what was presented, color blue seems to signal ADA right away which is not necessarily accurate, would like to see the iconic sailboat on the signs, would like to consider a larger map/directional trailhead type signage as part of CDOT’s plan, consider matching railings with corten finishes, and like the look of the Basecamp era wayfinding signs more

- Retaining wall finish- FACC would like staff to ask CDOT about the possibility for any of the retaining walls to be used as mural space which would require a flat surface, and the FACC preferred the middle two-tone design used near Breckenridge
 - Railings- FACC preferred a corten finish
 - Landscaping areas and public art- consider consistency with at least some of the south end median components and roundabout finishes and use trees/plantings to soften the built environment and FACC not interested in placing art in the roundabouts as they are smaller and in very busy areas- believe there are better spaces for public art in Frisco
 - CDOT Tunnel Mural Project- 45 minutes
 - Review the three designs and discuss next steps
 - FACC decided to go with the Pat Milbery design after reviewing all three designs that the FACC paid to have three artists refine
 - Sound and Lighting Workshops- Next steps
 - Got good feedback about both workshops
 - Look at another beginner and then look at an intermediate sound and lighting workshops (do 12-17 and then 18+) and songwriting workshops (Potential resource- Noah Lyman? From the High Rhodes record store)
 - Look at anime style illustration (album cover design) and how does this interact with coding
